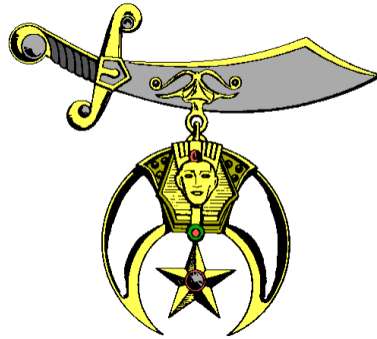

SEXUAL HARASSMENT POLICY



7. Imperial Treasurer's Report (Profit and Loss Budget – Actual). Period: January – December 2018. Discussion: Security and the Marshall's Departments.




